

Factors influencing calligraphy satisfaction in Shandong

Abstract

Calligraphy courses in colleges and universities not only cultivate students' knowledge of calligraphy theory and writing skills, but also expand students' cultural vision and increase their cultural confidence. Calligraphy course satisfaction is an important index to measure the level and quality of calligraphy teaching in schools. There are abundant educational resources in calligraphy courses in colleges and universities, and promoting the construction of calligraphy majors is conducive to giving full play to the unique and irreplaceable educational function of calligraphy courses. Based on the interview results of colleges and universities in Shandong Province, this paper analyzes the factors affecting the satisfaction of calligraphy courses in Shandong province, and puts forward countermeasures to improve the satisfaction of calligraphy courses, so that students can better appreciate the charm of calligraphy art and understand the connotation of traditional Chinese culture contained in calligraphy art. It is conducive to the inheritance and development of excellent traditional culture, and also conducive to the transportation of high-quality calligraphy professionals to the society.

Introduction

Shandong Province has a long culture of calligraphy and a profound history, and there are many outstanding calligraphers from Shandong Province, such as Yan Zhenqing, one of the "Four Great Masters of Regular Script", Zhang Xu, who is famous for his cursive script, and Wang Xizhi, who is known as the "Sage of Calligraphy". The "Lanting Preface" is also known as the "World's Best Running Script". Many foreign calligraphers, such as Su Shi, Ouyang Xiu, Fan Zhongyan, Fubi, Huang Tingjian, Mi Fu, Zheng Xie, Wang Shizhen, Kang Youwei, etc., also traveled to Shandong, leaving behind a large number of ink treasures in the land of Qilu, leaving the seeds for the development and transmission of modern Shandong calligraphy culture to take root.

Due to the differences in regional cultural traditions embodied by various calligraphers, the works of calligraphy in Shandong Province are diversified and make Shandong the epitome of China's calligraphy career. With the continuous development and transmission of calligraphy culture, most universities and hobby training institutions in Shandong Province offer calligraphy learning courses. The level of satisfaction with the calligraphy courses greatly reflects the teachers' understanding and mastery of calligraphy, and also reflects the transmission of calligraphy culture, and at the same time, the shortcomings in the learning process of calligraphy courses can be adjusted and corrected in time.

Literature Review

A search of the relevant domestic literature reveals that there are currently some difficult issues regarding calligraphy education.

Liu (2022) It was said: many schools do not pay much attention to calligraphy majors, they are not systematic enough in teaching, teaching resources are insufficient, teaching facilities and equipment and teaching environment need to be improved, campus culture atmosphere is not enough, employment in calligraphy is relatively narrow, students do not pay enough attention to calligraphy courses, calligraphy knowledge mastery and calligraphy skills connection is also insufficient, etc.

Chen (2020) It is said that calligraphy education in colleges and universities is dedicated to improving students' interest in learning and enhancing their calligraphy writing skills, but the current arrangement of calligraphy courses for students in colleges and universities lacks planning, holistic and professionalism, and the teaching objectives of calligraphy courses differ greatly from the actual teaching contents. Calligraphy courses should pay more attention to students' feeling ability and focus on students' calligraphy appreciation ability in teaching design.

Du (2019) It was stated that the teaching resources of calligraphy courses in colleges and universities are insufficient, the teaching system is not perfect, the teachers are weak, and the tools needed for teaching, such as practice paper and pens, do not meet the students' needs well. Teachers do not provide timely and effective feedback on students' work, and students' interest in learning is low, making the calligraphy course less satisfying.

Research significance

The paper examines the factors influencing the satisfaction of calligraphy courses in colleges and universities in Shandong Province based on the content of interviews.

The interviews will be conducted in five areas: the goal of offering a calligraphy course, the content of the calligraphy course, the way teachers instruct in class, teaching resources, and the evaluation of the calligraphy course, and the interview survey will be conducted from teachers to students, more comprehensively including the content related to the current stage of calligraphy

course learning.

During the interviews with teachers and students in colleges and universities in Shandong Province, we learned about the level of development and the current status of development of calligraphy courses in colleges and universities in Shandong Province, as well as existing problems, and based on the results of the interviews we can make suggestions for the development of calligraphy courses in Shandong Province.

Research Subjects

In this paper, we interviewed teachers and students from Qufu Normal University, teachers and students from Linyi University, and teachers and students from Shandong Institute of Arts and Crafts on "factors influencing the satisfaction of calligraphy in Shandong universities".

The study analyzed the factors influencing the satisfaction of calligraphy in colleges and universities in Shandong Province through five aspects: teaching objectives, teaching contents, teaching resources, teaching instruction and assessment.

Data Collection

Research Sample

The data in this study were obtained from interviews with teachers and students of Qufu Normal University, Linyi University, and Shandong Institute of Arts and Crafts in Shandong Province on the factors influencing satisfaction with calligraphy courses in Shandong Province. The interview questions were about "factors influencing satisfaction with calligraphy in Shandong universities" and "measures to solve the factors influencing satisfaction with calligraphy in Shandong universities", and the interviewees talked about teaching objectives, teaching content, teaching instruction, teaching resources and assessment.

Data Collation

The collected data were initially summarized and organized, and invalid samples were screened and eliminated to obtain the data for the study in the paper.

The data obtained were categorized to obtain the influencing factors and solution measures of teaching objectives, teaching resources, teaching instruction, teaching content and assessment in the satisfaction of college calligraphy courses. Based on the influencing factors and influencing measures obtained from the interviews, we analyzed the current situation of the development of college calligraphy courses and made suggestions for the development of college calligraphy courses.

Research Framework

Based on the results of the interviews, we explored the factors affecting the satisfaction of college calligraphy courses, analyzed the factors affecting the satisfaction of college calligraphy courses in the new era from five aspects: teaching objectives, teaching resources, teaching content, teaching instruction and assessment, and analyzed the solutions for higher satisfaction of college calligraphy courses in light of the development of the times and society. The study will analyze the solutions for higher satisfaction of college calligraphy courses in light of the development of the times and society.

Conclusions and findings

1. Factors influencing the course satisfaction of calligraphy teaching objectives in Shandong universities

As can be seen from Table 1, the main factors influencing the curriculum in terms of calligraphy teaching objectives are: learning a solid theoretical foundation, calligraphy creation and practical skills, and cultivating applied professionals.

Solid theoretical foundation

Among the interviewees, 10 mentioned the high degree of influence of cultivating students' solid theoretical foundation in the teaching objectives of calligraphy on satisfaction, and the interviewees talked about the training objectives of calligraphy as cultivating a comprehensive development of moral, intellectual, physical and aesthetic, solid basic theory, innovative spirit and practical ability, with the qualities of Yimeng spirit and international vision, systematic mastery of professional knowledge of calligraphy, strong professional skills and group cooperation The goal of the program is to train students with a solid understanding of basic theories, innovative and practical abilities, the spirit of Yimeng and an international perspective, systematic

knowledge of calligraphy, strong professional skills and the ability to cooperate in groups.

A solid theoretical foundation is a prerequisite and basic requirement for the learning and creation of calligraphy. Therefore, a solid theoretical foundation is an important factor in the satisfaction of calligraphy teaching goals in calligraphy courses, as well as in the construction of calligraphy courses in colleges and universities.

Li & Gao (2022) It was said: in the college calligraphy curriculum, whether it is a professional course in art or the improvement of Chinese character writing skills for teacher training students, it is necessary to focus on cultivating students' core competencies, tapping the school's high-quality resources, combining its own reality, grasping the key and difficult issues, and improving the course objectives, teaching contents, teaching methods, and teaching evaluation. Appropriately integrate elements of calligraphy culture curriculum thinking and politics, strengthen the study of calligraphy theory, pay attention to the connection between Mao et al. and hard characters, increase research activities, and comprehensively improve students' core competence in calligraphy.

Calligraphy creation and practical skills

Ten mentioned the high degree of influence of creative and practical skills on satisfaction, and respondents spoke of the pivotal role of calligraphy programs in building professional talent with superior creative skills.

The training objectives of calligraphy courses will directly feel the skills that students can learn and master. Reasonable training objectives can make students easily master the professional knowledge and theoretical skills they need to learn in a fun and educational environment, which has a pivotal role in students' future development. Therefore, the primary factor in the satisfaction of calligraphy courses in colleges and universities should be the training objectives of colleges and universities for calligraphy.

Liu (2022) It was said: applied colleges and universities cultivate calligraphy talents, which can serve the local cultural construction. Strengthen the cooperation between government and colleges, colleges and enterprises, colleges and various primary and secondary schools, colleges and communities, etc., sign internship and employment agreements, jointly cultivate and improve the comprehensive quality of calligraphy talents, and broaden the employment channels of calligraphy talents. Students with calligraphic expertise should have both calligraphic expertise and multidisciplinary knowledge, with comprehensive abilities to become complex talents who meet the needs of different positions.

Cultivate application-oriented professionals

Seven people mentioned the influence of cultivating application-oriented professionals on the satisfaction of calligraphy courses. This indicates that the goal of calligraphy teaching in colleges and universities should be based on cultivating students' solid theoretical foundation, calligraphy creation and practical skills, as well as calligraphy teaching should focus on cultivating applied professionals.

Highly qualified applied talents who can work in education, economy and other enterprises and management departments at all levels in calligraphy education, calligraphy creation and theoretical research, calligraphy and painting curation and other related fields, and who can adapt to the needs of regional economic and social development. A sound and reasonable training program is the key to student success and an important factor in student satisfaction with the calligraphy major program.

Zhu (2021) It is said that calligraphy course is a good carrier for students to understand Chinese traditional culture and an important way to enhance the humanistic quality of college students. By appreciating and studying classic calligraphic works from different historical periods, students are able to understand the spirit of Chinese culture embedded in them, thus enriching their minds, cultivating their temperament, establishing a correct aesthetic inclination, exercising their bodies and minds, and enhancing their own sense of national honor. Therefore, the quality education function of college calligraphy courses is multifaceted.

2. Factors affecting the satisfaction of calligraphy teaching resources on courses in Shandong Province universities

As can be seen from Table 2, the main factors influencing the curriculum of calligraphy teaching objectives are: having a special calligraphy classroom with strong resources, inviting famous teachers to give lectures, and establishing internships, practical training bases and research bases.

Strong Faculty

Among the interviewees, six mentioned that strong faculty in calligraphy teaching resources had a high impact on satisfaction, and that the teaching of calligraphy courses in colleges and universities should be strengthened with strong faculty, which is an important part of ensuring teachers' professional knowledge and theoretical and practical guidance for students. Respondents mentioned that the school's calligraphy program has a combined full-time and part-time faculty with high professional level and strong practical ability, and corporate industry experts participating in practical teaching, equipped with special practical training rooms and calligraphy and painting practical training rooms, and complete hardware and software facilities, which can better meet the needs of each of this program's on-campus practical teaching.

Liu et al. (2015) stated: in fact, professional and qualified calligraphy teachers are few and far between, and currently there are many private colleges and universities to solve the shortage of calligraphy teachers by hiring professional teachers outside the school to teach, and some even find professional teachers who are similar to calligraphy majors to teach. As a result of these problems, some of them do not guarantee the normal quality of teaching, from which many problems can arise, such as. Insufficient knowledge of the calligraphy profession. There are misconceptions in teaching methods, poor teaching results and other phenomena. Therefore, from the perspective of the construction of calligraphy courses in private colleges and universities, this problem should be solved in a timely manner, and school leaders and academic management departments should pay attention to the construction of calligraphy courses and other professional courses, and treat the issue of teachers' qualifications as seriously as other courses. The teacher should be equipped with professional teachers in order to teach students effectively and to provide them with a higher level of training.

Invite famous teachers to give lectures

Five respondents believed that inviting famous teachers to give lectures could improve the influencing factors of satisfaction with calligraphy teaching goals. Respondents noted that hiring experts with corporate industry backgrounds with participate in teaching activities and guide students to participate in various competition activities at all levels can better cultivate a solid

theoretical foundation in calligraphy, strong cultural and artistic literacy, calligraphy expertise, innovative spirit and entrepreneurial consciousness, and equip students with solid professional basic knowledge and skills in calligraphy creation.

With a professional teaching team and actively absorbing the excellent teaching experience and achievements of other institutions across the country, employing experts in calligraphy creation and theoretical research at home and abroad to hold lectures, and taking advantage of the very rich conditions of Shandong's regional inscription materials to make teaching and cultivation more distinctive. Employing renowned experts and scholars to hold special lectures not only enriches the information of teaching and research, but also greatly broadens the professional and cultural horizons of students.

Construction of a practical training base and a special calligraphy training room

Five people mentioned that the establishment of special training bases and research bases could enhance the satisfaction of teaching resources, and four people mentioned the establishment of special calligraphy classrooms to enhance the satisfaction of teaching resources.

The interviewees talked about the perfect teaching facilities and the beautiful teaching environment, which provide a strong guarantee for the smooth teaching of calligraphy majors. The various hardware and software facilities are well equipped to better meet the needs of calligraphy students' on-campus practical teaching.

Liu (2022) Said: Campus culture plays a vital role in student learning, and a good cultural atmosphere should be created when conducting calligraphy education, such as holding traditional calligraphy competitions, conducting activities such as calligraphy knowledge contests, and giving students extra points on comprehensive assessments or issuing prizes and certificates.

Hao (2021) It is said that multimedia teaching equipment brings convenience to calligraphy education college teachers should make the content of calligraphy education fully integrated with multimedia equipment to carry out more efficient calligraphy education activities. With the help of multimedia devices, college teachers can add pictures and videos corresponding to calligraphy to their courseware when conducting calligraphy education, presenting the course content to students in a more vivid form as a way to motivate students to learn calligraphy knowledge. The use of multimedia to present videos or materials can better stimulate students' interest in learning, as well as cultivate students' initiative in learning calligraphy and help them develop good learning habits.

3. Factors influencing the content of calligraphy teaching on course satisfaction in Shandong universities

As can be seen from Table 3, the main factors influencing the content of calligraphy instruction on the curriculum are: improving literary and cultural literacy, learning theoretical knowledge of calligraphy, learning calligraphy practice and writing skills, and research and discussion of the history of calligraphy.

Calligraphy practice and calligraphy technique learning

Thirteen people mentioned that calligraphy practice and learning calligraphy skills enhance satisfaction with teaching resources. With more than 50% of the total number of respondents, calligraphy practice and learning calligraphic skills have a high impact on satisfaction in the content of instructional courses and are the main content of calligraphy courses in colleges and universities. Respondents noted that professional foundation courses in calligraphy teaching are designed to shape students to form the basic competencies of the calligraphy discipline. The main professional courses cover theoretical courses such as paleography, calligraphy aesthetics, ancient calligraphy theory, and the history of Chinese calligraphy education, along with compulsory professional courses that further deepen learning based on the professional foundation courses, such as the practice of line calligraphy creation, the practice of cursive

calligraphy creation, thematic studies of classic stelae and posters, the foundation of Chinese painting, the study of calligraphy, and calligraphy curriculum and pedagogy, to shape students' comprehensive and solid skills and calligraphy. The curriculum fully reflects the characteristics of the program, which combines theoretical research with the creation of calligraphy and seal carving, and emphasizes the cultivation of calligraphy education.

Yang (2010) It is stated that the teaching of calligraphy course is based on the theoretical knowledge framework of Chinese calligraphy history, calligraphy aesthetics, calligraphy appreciation, and calligraphy theory of all generations. The basic content of learning is the seal script, official script, regular script, running script, and cursive script; the focus of learning techniques is the use of strokes, knots, and chapters of various calligraphic styles; and the core of teaching practice is the practice of tombstoning and creation, which intertwine to form the body of calligraphy teaching. At the same time, the study of calligraphy also involves a number of disciplinary areas, such as the tracing of calligraphic strokes to their origins, the appreciation of calligraphic works to calligraphic aesthetics, calligraphic criticism, general art theory, and Chinese art history, and the creation of calligraphic works to literature, philosophy, and art psychology. This rich array of disciplines in the art of calligraphy requires that the teaching of calligraphy should not be limited to the knowledge of calligraphy itself, but should also address the relationship with these disciplines, so that students can learn calligraphy while also acquiring knowledge of related disciplines.

Study of theoretical knowledge of calligraphy

Nine respondents noted the influence of learning theoretical knowledge of calligraphy on content satisfaction in calligraphy courses, and the respondents mentioned that the learning of calligraphy content begins with learning theoretical knowledge of calligraphy.

Interviewees pointed out that college calligraphy courses introduce the content, requirements and methods of learning calligraphy techniques, reinforce the development of competence as the main driver of copying training, and achieve purposeful technique training. It is important to make it clear to students that learning calligraphy techniques in college is different from the past, to focus on the development of skills, and to strengthen the purpose of training. The teacher guides the students to develop a new learning philosophy, where technique and theory are mastered simultaneously.

Through the history courses on the history of calligraphy and seal carving, students focus on cultivating the aesthetic ability of comprehensive analysis, linking theory to practice, and continuous optimization of the knowledge structure, mastering the knowledge of the evolution of calligraphic style, the evolution of technique, the development of style, the history of communication and the history of theory and criticism, and emphasizing the ability to study the

history of calligraphy and express the aesthetic and intellectual qualities of calligraphy and seal carving to meet the needs of society for calligraphic talents.

Improving literary quality and cultural literacy

Seven respondents noted the impact of improving literary quality and cultural literacy on content satisfaction in calligraphy courses, and the respondents mentioned that learning calligraphy lies in more than just calligraphic skills. The practice and learning of calligraphy must keep up with the times, and there is also a need to put the improvement of literacy above writing.

In the construction of the calligraphy curriculum, in addition to the learning of professional knowledge and skills, it is also necessary to emphasize comprehensive cultural quality, focus on cultural cultivation, and cultivate a comprehensive quality of professional talents.

Jin (2020) It has been said that calligraphy education in colleges and universities is not only the teaching of a skill, but also the inheritance and continuation of the Chinese culture. For every college student, it is a way to pass on the meaning of culture through individual professional learning and to receive an artistic education. There are many examples in history of people who have been changed by calligraphy, and by learning calligraphy, we can improve our personal skills and contribute to the revitalization of our culture. Currently, the love of calligraphy is essentially a love of our traditional culture, and so is the goal of calligraphy education in higher education.

Research and discussion on the history of calligraphy

Seven respondents noted the influence of research and discussion of the history of calligraphy on content satisfaction in calligraphy courses, and respondents mentioned that focusing on the study and learning of the history of calligraphy inspires students to be interested in the history of calligraphy.

Through the content of the history of calligraphy and the study of calligraphy theory, students are guided to learn to learn independently, to understand that calligraphy is more than just writing, to make students understand the change in connotation of calligraphy from the ancient scholarly environment to the present day construction of the discipline, and to be clear about the direction in which students should strive for the study of calligraphy.

Jin (2020) It is said: writing is the basic language of every country and nation, and Chinese characters are only found in China. Chinese characters have been developed and evolved with the history of Chinese civilization for five thousand years. Chinese characters have recorded the development of a country's culture and history, and have recorded the content of knowledge, culture, information, academics, and other aspects. Calligraphy is a form of art that uses Chinese

characters as a carrier and is the main form of expression of Chinese characters. By learning the art of calligraphy, one can feel the connotation of ancient Chinese characters through their beauty and can deeply appreciate the wisdom of the ancient Chinese people and the kind of intentions of the Chinese craftsmen, thus enhancing national self-confidence and pride.

4. Factors influencing the satisfaction of calligraphy teaching instruction on the course in Shandong Province universities

As can be seen from Table 4, the main factors that influence the curriculum of calligraphy teaching instruction are: inheriting the excellent traditional art of calligraphy, using online resources for learning, meeting the requirements of today's social development for talent training, and strengthening the guidance and inspiration for fellow students.

Meet the requirements of today's social development for human resources training

Six of the interviewees mentioned the influence of meeting the requirements of today's social development for talent training on satisfaction with calligraphy courses, for example, interviewee 20 mentioned: integrating traditional culture and modern civilization to meet the requirements of today's social development for talent training.

Yang (2010) The five calligraphic styles - seal script, official script, regular script, running

script, and cursive script - are used as the basic learning content, and the techniques of calligraphy - brushwork, knotting, and chapter - are used as the main elements of learning, while the skills of tombstoning and creation are the core of practical training. Each stage has its own training topics and requirements, and different training methods can be used, for example, the primary stage is focused on the proscenium, the intermediate stage is focused on poems, songs and quotations, and the advanced stage is focused on the creation of works of different sizes and styles. At the same time, the diversity of training methods should also be combined with students' learning methods, such as problem-solving learning, case study method, etc. Training methods that can be suitable for students' inquiry learning should be the best methods.

Learning with online resources

Five respondents mentioned the use of online resources for learning, and respondents noted the use of online resources for learning and skills training, and effective training through a combination of online self-study and on-site training.

Li & Gao (2022) It has been said: students' horizons are infinitely expanded, knowledge reserves are no longer the focus in teaching and learning, what students need more is to enhance their independent learning ability and learn to learn, which makes it necessary for curriculum reform to fully explore and utilize information technology, such as: using platforms such as MU class, actively promoting the reform of online and offline hybrid teaching methods, especially to strengthen the design of research-based learning activities.

Reinforcing guidance and inspiration for classmates

Five interviewees mentioned strengthening the guidance and inspiration of students. The interviewees talked about the principle of combining theory and practice in teaching, using special topics or lectures to strengthen the guidance and inspiration of students, teaching the knowledge and techniques of excellent Chinese traditional culture in a way that is pleasing to students; finally, combining what students see in their daily lives with calligraphy demonstrations to strengthen the inspiration of students, focusing on the humanities and aesthetic ability of students. The course is designed to meet the needs of society by combining the characteristics of the local economy and industrial structure and the demand for talents, and by combining the curriculum with the characteristics of the calligraphy major; taking a combination of compulsory and optional courses, and offering corresponding courses according to the needs of the training direction.

Ding (2018) It was said: the amount of class time and the semester in which the course is offered can be increased to ensure sufficient time for study and training. Establish a calligraphy teaching and research department, which will work together to revise the complete syllabus and examination syllabus to make the training system more complete. The content and practice of the classes should be adjusted to the needs of different majors, e.g., the courses for preschool

education and elementary education majors should be designed differently. We will offer multiple semesters of elective courses in the art of calligraphy, so that students will have classes to choose from in addition to their basic classroom studies, so that they will have more training and extend their artistic developmental specialties.

Inherit the excellent traditional calligraphy culture

Four mentioned inheriting excellent traditional calligraphic culture, and the interviewees noted the emphasis on the foundations of Chinese studies, the importance of cultural cultivation, and the inheritance and development of calligraphic culture and the art of calligraphy.

Bai (2022) It was said: calligraphy is the treasure of excellent Chinese traditional culture and art, and in today's world where Chinese and Western cultures collide and mingle, maintaining the roots of Chinese calligraphy culture is crucial to promoting excellent Chinese traditional culture and promoting its creative transformation and innovative development. With the rapid development of technology, the popularity of the Internet, and the profound changes in the way modern information is exchanged, calligraphy has moved away from being practical, and the historical culture and humanistic spirit it contains has taken on the important task of enhancing the cultural self-confidence of the nation and raising the international influence of traditional Chinese culture.

5、 The factors influencing the satisfaction of the course by calligraphy assessment (evaluation) in Shandong Province universities?

As can be seen from Table 5, the main factors that influence the assessment of calligraphy teaching on the curriculum are: self-assessment, mutual assessment among students, establishment of a fair assessment mechanism, assessment of students by teachers, and assessment by conducting calligraphy competitions.

Mutual assessment among students

Six of the interviewees mentioned the influence of mutual assessment among students on their satisfaction with the calligraphy course, for example, interviewee 2 mentioned: establishing study groups and conducting mutual assessment among students. Through students' mutual assessment, they can learn from their classmates' strengths and make up for their own weaknesses.

The teacher assesses the student

Five interviewees mentioned teachers' assessment of students. The interviewees talked about how teachers can improve students' enthusiasm for learning through comprehensive assessment of students' assignments, attitudes, etc. The interviewees talked about that in educational assessment, a variety of assessment methods should be used flexibly in conjunction with teaching needs, and self-assessment and mutual assessment can be used in the assessment process. A fair assessment and evaluation mechanism is established to assess students' learning through the final assessment, and a sound and fair teacher evaluation mechanism is established to ensure that they treat each student fairly and impartially. Teachers give students different levels of evaluation according to their attitudes and emotions in the learning process and specific details in their writing practice, as well as their ability to use their skills.

Peng & Yi (2021) It is stated that: teacher evaluation is the core part of teaching evaluation. The final end-of-semester grade evaluation of a calligraphy student was diversified, and the instructor's evaluation was only one of the important components that accounted for the greatest weight. After the implementation of diversified evaluation by the calligraphy faculty, students in these classes greatly recognized the results of teaching evaluation and had a significant increase in their learning initiative.

Calligraphy competition

Three people mentioned conducting calligraphy competitions, with respondents noting the use of mini-essays, combined with regular assignments, to comprehensively assess learning in the calligraphy course, to conduct competitions for calligraphy works, to learn from other students' good calligraphy skills and innovative points, and to find their own shortcomings in the calligraphy competition.

Peng & Yi (2021) It was said: actively promote the exploration and practice of teaching evaluation reform, and give full play to the role of calligraphy teaching and research office in

teaching quality monitoring and supervision. Involving students in the evaluation of calligraphy courses, students can not only conduct self-assessment and mutual evaluation, but also evaluate teachers' course teaching. Teachers put the converted component values of student self-assessment and mutual assessment into the students' final grades with appropriate weights, avoiding one-sidedness and subjectivity in evaluating students, and, at the same time, through the feedback from students in evaluating the course.

Conclusions and Recommendations

Conclusion

1、 Solutions to the factors influencing the satisfaction of calligraphy teaching objectives on courses in Shandong Province universities

The solutions to the factors influencing the course satisfaction of calligraphy teaching objectives in Shandong Province colleges and universities mainly focus on combining professionalism and interest, cultivating students' comprehensive quality, responding to the requirements of the times and the development of the era, and fostering students' innovation and creativity.

The specification requirements of both professional setting and talent training should be close to the characteristics of local economy and industrial structure and the situation of talent demand. In the curriculum system, the curriculum must be set with clear objectives and a clear structure. That is, for students' knowledge level, technical level, ability level and comprehensive literacy level, there are clear distribution. Optimization in terms of class time rationing and chronological articulation It is necessary to determine the reasonable ratio of theoretical and practical courses, public and professional courses, planned and independent courses by dissecting the training program and adjusting them in a timely manner according to the needs of the times.

2、 The solution to the influence of calligraphy teaching resources on course satisfaction in Shandong universities

The solutions to the factors influencing the satisfaction of calligraphy teaching resources on the course in Shandong universities mainly focus on establishing a network information platform, strengthening the construction of teachers, inviting professional scholars to give lectures, cooperating with social enterprises or other universities, sharing resources, and introducing multimedia teaching equipment.

Ren (2019) It has been said: the good or bad teaching conditions affect the teaching results to a certain extent. Due to the special nature of calligraphy, in addition to some hardware facilities that should be available, multimedia teaching, libraries, museums including a large number of printed realistic and even original reference materials are necessary materials, in addition to this colleges and universities should plan and establish as soon as possible the specification of

teaching equipment for college calligraphy majors, the tuition fees paid by students should be used for students, to equip the calligraphy majors with suitable necessary tables and chairs media, calligraphy and painting pro tomb room, framing In addition to this, colleges and universities should plan and establish specifications for the equipment used to teach calligraphy in colleges and universities.

3、 The solution to the influence of the content of calligraphy teaching on course satisfaction in Shandong Province universities

The solutions to the factors that influence the content of calligraphy teaching on course satisfaction in Shandong universities focus on promoting traditional Chinese culture, guiding students' personality expansion and artistic innovation, calligraphy creation and appreciation, and strengthening skill training.

With the aim of adapting to the future needs of society, we teach the knowledge and techniques of Chinese traditional culture in the classroom in a way that is pleasing to the students. First of all, students will know the historical development process of calligraphy, the important place it occupies in the development of human art as a whole, and what the aesthetic value of the art of calligraphy is, not what ideological content is contained in it. So we need to let students know what calligraphy is. We want students to know what role it has played in history.

Bai (2022) It is said that, according to its own advantages and characteristics, the teaching content of general education of calligraphy in colleges and universities is divided into four modules: one is the history of Chinese calligraphy, the second is the appreciation of classic Chinese monuments and stelae, the third is the practical experience of calligraphy copying, and the fourth is the creation of calligraphic works. The different types of courses can expand the field of calligraphy aesthetic education, strengthen the integration of theoretical teaching and practical experience, and build and gradually improve the "basic knowledge, core literacy, special strengths" of the calligraphy aesthetic education curriculum system.

4、 Solutions to the factors influencing the satisfaction of calligraphy teaching instruction on the course in Shandong Province universities

The solutions to the factors influencing the course satisfaction of calligraphy teaching instruction in Shandong universities focus on advocating diversified teaching instruction, personalized instruction on students' creative strengths and weaknesses, stimulating students' interest in learning, and teachers' classroom lectures on calligraphy to guide students' independent learning.

Calligraphy education is about simplifying the complex and esoteric theories and practices of

calligraphy, allowing students to fully and profoundly experience the joy they contain, giving them the initiative to learn, and fully mobilizing their learning initiative. Calligraphy begins with the use of the brush, is based on structure, becomes a chapter, and is beautiful in its rhythm.

5、 Solutions to the factors influencing the satisfaction of the course by calligraphy assessment (evaluation) in Shandong Province universities

The solutions to the factors influencing the satisfaction of calligraphy assessment on the course in Shandong universities mainly focus on the evaluation in the form of work reporting, timely feedback of the assessment content, strengthening the communication between students and teachers, and evaluation by essay writing.

Theoretical courses in calligraphy allow students to master the basics, and at the same time, students are regularly required to write short essays to improve their overall literacy skills.

The assessment of the technique course can be carried out in the form of work report exhibition, the presentation of the final work is a display of the semester's learning achievements, which can motivate students to create their works, and the exhibition effect is conducive to mutual learning and common progress among students.

Recommendation

1. Suggestions on the factors influencing the satisfaction of the course on the teaching objectives of calligraphy in Shandong Province universities

Suggestions for factors influencing course satisfaction with the objectives of calligraphy teaching in Shandong universities

Combining the development trend of the times, adding new goals that are in line with the development of the times, focusing on students' innovation and entrepreneurship and practical ability cultivation, the curriculum should follow a combination of professionalism and interest, where students are trained in systematic skills as well as systematic study of calligraphy theory, with a certain ability to research and create calligraphy, and cultivate students' comprehensive quality.

The number of courses within the teaching plan should be optimized, core courses and related courses and extension courses should be established, and the actual needs of students should be taken into account, so that professional knowledge and their own interests can be combined. In the curriculum system, whether in terms of the structural model of the system, the choice of professional direction, the total number of hours and the ration of class time, the overall development and individual differences of students should be fully considered, so as to cultivate a

solid foundation of calligraphy theory, a Strong cultural and artistic literacy, specialized skills in calligraphy, innovative spirit and entrepreneurial consciousness, and solid professional basic knowledge and skills in calligraphy creation.

2. Suggestions on the factors influencing the satisfaction of calligraphy teaching resources on courses in Shandong Province universities

Suggestions for factors influencing course satisfaction with calligraphy teaching resources in Shandong universities

Any scientific curriculum system can not leave the basic resources to protect, first of all, the teacher team to protect. At present, there is no lack of teachers who can teach theory, what is lacking is the "dual-teacher" teachers who understand both theory and technology and application.^[4] The lack of "dual-teacher" teachers who understand both theory and technology and application. We should encourage teachers to go to the front line of practice to understand the production process and application technology, and at the same time, we can also actively absorb a group of teachers who know technology to the school and classroom; at the same time, we should strengthen the exchange between institutions and enterprises, so as to truly shape a group of excellent teachers who can adapt to the application-oriented talents.

Yang (2012) It was said: strengthen the construction of teachers, increase the introduction of calligraphy doctoral efforts, improve the introduction of doctoral treatment, as China's calligraphy doctoral talent shortage, can introduce well-known institutions of outstanding calligraphy master's degree, to organize teachers from time to time out of training, strengthen external exchanges, improve teaching, scientific research, creative level. Employing well-known experts and scholars from other institutions as visiting professors, inviting nationally renowned calligraphy education majors to the school from time to time to conduct lectures, or teaching lecturers on a part-time basis, will not only enrich students' professional academic knowledge, broaden their horizons and increase their insight, but also strengthen teaching and academic exchanges among teachers.

3. Suggestions on the factors influencing the content of calligraphy teaching on course satisfaction in Shandong universities

Suggestions for factors influencing the content of calligraphy instruction on course satisfaction in Shandong universities

The content of calligraphy should be integrated with the history, reality and future development of the school. In the past, the content of calligraphy was taught in a history-based, unstaged manner, and students were taught from elementary school through college in one

period. One disadvantage of this approach is that it tends to create a kind of learning inertia in students. Therefore, some new content can be added to the calligraphy curriculum to make students understand that Chinese calligraphy is an ancient yet young discipline that requires constant study and exploration, and to stimulate their strong interest in learning calligraphy. Currently, the state advocates Chinese culture and national education, and the promotion of classical culture in traditional culture should be placed in an important position to grasp.

Wang (2020) It is a good opportunity for the students to learn calligraphy. Since calligraphy is one of the subjects in the catalog of higher education, many excellent applied colleges and universities can cultivate a large number of calligraphy professionals for China by virtue of their profound schooling and resources, These professionals have a wide range of professional knowledge and skills, as well as cultural, humanistic, and creative abilities, which will not only help them in future calligraphy creation and theoretical research, but also in calligraphy teaching and calligraphy art related education or management, effectively promoting the succession and development of the calligraphy profession.

4. Suggestions on the factors influencing the satisfaction of calligraphy teaching instruction on the course in Shandong Province universities

Suggestions for factors influencing course satisfaction of calligraphy teaching instruction in Shandong universities

We advocate diverse teaching guidance, personalized instruction on the strengths and weaknesses of student creation, stimulating students' interest in learning, and teacher classroom lectures on calligraphy to guide students' independent learning.

The teacher writes on the spot in class while explaining the conception of calligraphy chapters and the usage of creation, impressing students with beautiful things, inspiring them with excellent works, and cultivating them with noble sentiments, so that they can taste the sweetness of learning calligraphy, feel the charm of the art of calligraphy, and stimulate their interest in learning.

From a single mode of teaching to a multi-channel and multi-path approach, we make full use of platforms such as professional calligraphy websites, student QQ groups and online classes, and use classroom exchanges and discussions to teach close to students' calligraphy level, using diversified teaching methods.

5. Suggestions on the factors influencing the satisfaction of the course in the assessment (evaluation) of calligraphy in Shandong universities

Suggestions for factors influencing course satisfaction in calligraphy assessment in Shandong universities

In order to let students really learn and reflect the effect of the assessment, we must strengthen the feedback of the assessment results. The assessment process and results will be analyzed in a report, from the course to the class and then to each student, and feedback will be given to the students on the analysis results and problems, so as to analyze and improve the problems together. The communication between teachers and students is strengthened to help students absorb and understand the knowledge.

The assessment of the technique course can be carried out in the form of work report exhibition, the presentation of the final work is a display of the semester's learning achievements, which can motivate students to create their works, and the exhibition effect is conducive to mutual learning and common progress among students.

	and related courses and extension courses should be established, and the actual needs of students should be taken into account, so that professional knowledge and their own interests can be combined
3	Based on the actual needs of students, systematically mastering the professional knowledge of calligraphy, having strong professional skills and the ability to cooperate in groups, and cultivating the comprehensive quality of students
4	To adapt to the needs of regional economic and social development as the training goal
5	Highly qualified applied talents in the art of calligraphy who can work in education, publishing, training, crafts, design and other related industries, teaching calligraphy, editing, framing, transmission, pottery and other related work
6	Cultivate a solid foundation in calligraphy theory, strong cultural and artistic literacy, calligraphic expertise, innovation and entrepreneurial awareness, and solid basic knowledge and skills in calligraphy creation
7	A broad professional knowledge of the subject of calligraphy, strong professional skills in calligraphy, a broader cultural perspective, and good overall quality and innovative ability
8	Practical senior professionals who can be competent in calligraphy creation, calligraphy theory research, calligraphy teaching and comprehensive application of calligraphy art.
9	Cultivate professional talents with solid professional foundation and excellent creative ability, high quality talents with deep traditional cultural heritage and artistic innovation ability
10	In the curriculum system, no matter from the structural mode of the system, the choice of professional direction, the total number of hours and the ratio of class time, etc., we should fully consider the overall development and individual differences of students, combining the major and their own interests
11	Cultivate comprehensive talents with solid knowledge and skills in calligraphy education and the ability to create calligraphy, as well as basic knowledge and skills in basic art education, with certain humanistic qualities, professionalism, and a high level of comprehensive talent
12	Senior applied professionals who can work in various schools at home and abroad in calligraphy education and creative research

5	Introduction of multimedia teaching facilities and establishment of a calligraphy practice base to enrich students' theoretical knowledge and learn in a good

	teaching environment
6	At present, there is no shortage of teachers who can teach theory, what is lacking is "dual-teacher" teachers who understand both theory and technology and application.
7	Strengthen the construction of faculty, increase the introduction of calligraphic doctors, and improve the introduction of doctoral treatment
8	Since there is a shortage of calligraphic doctoral talents in China, excellent master's degrees in calligraphy from well-known institutions can be introduced. We should organize occasional training trips for teachers to enhance outside exchanges and improve teaching, research and creation.
9	We employ renowned experts and scholars from other institutions as visiting professors, and from time to time invite nationally renowned calligraphy education majors to the school to conduct lectures or teach lecturers on a part-time basis, which not only enriches students' professional academic knowledge, broadens their horizons and increases their insight, but also strengthens teaching and academic exchanges among teachers.

4	Let students taste the sweetness of learning calligraphy, feel the charm of the art of calligraphy, and stimulate their interest in learning
5	Calligraphy education is a way to simplify the complex and profound theories and practices of calligraphy and to allow students to fully and deeply experience the joy contained therein, thus stimulating their interest in learning

Q5: What are the measures to solve the factors influencing the satisfaction of the course by the assessment (evaluation) of calligraphy in Shandong universities?

1	Motivate students by reporting their work
2	The assessment should be feedback-based. The question paper should increase the variety and flexibility of questions and avoid the memorization of mechanical knowledge points.
3	Assessment should be diverse and hierarchical, increase process assessment, and provide timely feedback on assessment content
4	The following aspects can be used as assessment criteria: classroom performance, the level of participation in the classroom, and the ability to motivate students to think positively
5	After-school assignments are a very important aspect of the calligraphy course.
6	In order to improve the professional technique, first of all, we must have a certain awareness of the ability, a large number of writing is a necessary prerequisite for awareness, there must be an accumulation of practice, in order to achieve a qualitative leap, so after-class assignments can be used as one of the conditions of professional assessment methods
